## Who is responsible for processing personal data?

## What is the purpose of processing the data?

We process personal data for the following purposes:

- Contact: To handle inquiries received through contact forms.

- Telephone support: To attend phone calls. Calls may be recorded for quality purposes, with prior notice. - Recruitment: To manage CVs and participate in selection processes.

- Customer services: To manage customer registration and data for service delivery, including financial details for billing.

- Service information: To provide information related to our services during the customer relationship.

- Marketing after service: With explicit consent, to send promotional materials after the relationship ends. - Group promotions: With consent, to share or send promotional information from other companies in our group.

- Supplier data management: To handle supplier data strictly for commercial relationships.

- Video surveillance: For security purposes in designated areas, clearly indicated.

- Website users: For analytics and navigation information via cookies.

- Other channels: Data received through email, social networks, or WiFi registration.

### Legal basis for processing data

- Pre-contractual relationship: For quotations or job applications.

- Contractual relationship: For clients and suppliers.

- Legal obligations: For tax reporting or law enforcement.

- Consent: For marketing communications and cookies.
- Legitimate interest: For video surveillance or inquiry forms.

### **Data sharing**

- Public authorities: As legally required (e.g., police or tax authorities).
- Banks: For billing purposes.
- Group companies: Only with explicit consent.
- Service providers: Under data processing agreements (e.g., IT, legal, hosting).

### Data retention period

- We retain data only as long as necessary.
- Tax data: Stored as required by tax laws.
- Consent-based data: Until revoked.
- Surveillance footage: Up to one month unless needed for legal reasons.

### Your rights regarding your data

- Right to know if we process your data.
- Right to be informed at data collection.
- Right to access your data.
- Right to rectify inaccurate data.
- Right to delete your data.
- Right to restrict processing.
- Right to data portability.
- Right to object to processing.
- Right to opt-out of marketing communications.
